WHEREAS, the Novaliches Area is located at the northern part of the Gay adjacent to the Novaliches watershed and near the political boundary of the upper Caloocan City;

WHEREAS, the area is the gateway of the city from the neighboring tiles of Caloocan and San Jose Del Monte of Bulacan interconnected by Cairino Highway;

WHEREAS, in the past, Novaliches Area in Quezon City was least inveloped and tagged as one of the most neglected places in Metro wanda:

WHEREAS, with the development that is transpiring in Novaliches, area is now catching up with its more progressive neighbors and will nove that it can herald a new era of boom in Quezon City;

WHEREAS, to enably serve the constituents of Novaliches Area and the benefit of public service, a district office must be established.

NOW, THEREFORE,

SECTION 1. There is hereby established a Novaliches District Office of osciorganization structure, duties, functions and responsibilities are unided or defined in the attached supporting documents, consisting of the pages which are made integral parts of this ordinance.

SECTION 2. The head of the office created under SECTION 1 hereof will have the rank and salary of a regular office of the Quezon City opernment, and the salaries and emulements of the positions created bearing shall be in accordance with the provisions of Republic Act No. 2008 and other applicable laws rules and regulations.

The position of the Office Head is hereby declared primarily confidential and co-terminus with the term of the office of the appointing enthority, and his appointment is subject to the confirmation of the City entholic.

SECTION 3. The present personnel of the Novaliches District Center hereby absorbed into the office established under Section 1 hereof to given appropriate position titles without reduction in salary, seniority and other benefits. Funds provided in the 2011 Annual Budget for absorbed offices shall all be used as the initial budgetary allocation withis office.

SECTION 4. The creation of the Novaliches District Office shall be start the direct control and supervision of the Office of the City Mayor.

SECTION 5. This Ordinance shall take effect upon its approval.
