ORDINANCE NO. SP- 2074, S-2011

AN ORDINANCE ALLOWING ONE-SIDE PARKING IN CERTAIN STREETS OF BARANGAY SACRED HEART FROM TOMAS MORATO TO 11<sup>TH</sup> JAMBOREE, SCOUT FUENTEBELLA, SCOUT FERNANDEZ, SCOUT GANDIA AND SCOUT RALLOS, AND PROVIDING PENALTY FOR VIOLATION THEREOF.

WHEREAS, Section 458 (a) (5) (v) and (vi) of Republic Act 7160, otherwise known as "The Local Government Code of 1991", provides for the powers, duties, functions of the Sangguniang Panlungsod:

(v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same xxx.

(vi) Regulate traffic on all streets and bridges, prohibit encroachments or obstacles thereon and, xxx

*“A Resolution Urging the City Council to Create an Ordinance Authorizing the Sangguniang Barangay of Sacred Heart to Implement One-Side Parking of Motor Vehicles in Certain Streets of Barangay Sacred Heart from Tomas Morato to 11<sup>th</sup> Jamboree, Scout Fuentebella, Scout Fernandez, Scout Gandia and Scout Rallos”;*

*WHEREAS, the Department of Public Order and Safety (DPOS) interposes no objection to the proposed measure of the barangay and submitted an inspection report as to the feasibility and practicality of implementing one-side parking;*

*WHEREAS, the barangay experiences massive complaints due to the continuous problem on vehicular traffic on a daily basis;*

*WHEREAS, there is a necessity to implement a one-side parking scheme along certain streets of Barangay Sacred Heart to restore order and discipline within the area;*

*WHEREAS, it is incumbent upon the City Government to regulate the traffic situation and road conditions within its jurisdiction.*

**NOW, THEREFORE,**

**BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:**

**SECTION 1. TITLE – This Ordinance shall be known and referred to as “One-Side Parking Scheme of Barangay Sacred Heart.”**

**SECTION 2. STREETS COVERED – The following streets shall be:**

- a) Tomas Morato to 11<sup>th</sup> Jamboree
- b) Scout Fuentebella
- c) Scout Fernandez
- d) Scout Gandia
- e) Scout Rallos

**SECTION 3. HOURS COVERED – The One-Side Parking Scheme shall be observed from 7:00 a.m. until 9:00 p.m., Monday to Saturday.**

**SECTION 4. ENFORCEMENT – This ordinance shall be enforced and implemented by the Department of Public Order and Safety (DPOS) and by the Barangay Public Security Officer (BPSO) of Barangay Sacred Heart.**

**SECTION 5. INSTALLATION OF ONE-SIDE PARKING SIGN** – The Department of Public Order and Safety (DPOS) is hereby mandated to install a one-side parking sign on the above-mentioned areas to inform motorists, drivers, vehicle owners and the public in general.

**SECTION 6. PENALTIES** - Any person or persons found violating the provisions of this Ordinance shall be penalized with a fine of not less than one thousand pesos (P1,000.00) but not more than five thousand pesos (P5,000.00).


**SECTION 7. REPEALING CLAUSE** – All existing ordinances and resolutions, local executive orders, rules and regulations inconsistent with any of the provisions of this ordinance is hereby repealed and/or modified accordingly.

**SECTION 8. EFFECTIVITY** - This ordinance shall take effect immediately upon its approval.


