AN ORDINANCE AMENDING ORDINANCE NO. SP-1155, SERIES OF 2002, CHANGING THE DATE OF CELEBRATION OF THE BARANGAY DAY FROM OCTOBER 2 TO SEPTEMBER 21 EFFECTIVE SEPTEMBER 21, 2011 AND EVERY SEPTEMBER 21st OF EVERY YEAR THEREAFTER.

WHEREAS, City Ordinance No. SP-1155, S-2002 declared the 2nd day of October as Barangay Day in Quezon City;

WHEREAS, the celebration of the Barangay Day will be more suitably held in September of each year, it being declared as the Local Government Month by virtue of Presidential Proclamation No. 114 issued on Sctober 10-2001, signed by Executive Secretary Alberto G. Rolling Professions

WHEREAS, the City Government, through the City Mayor and the City Council, desire to give due recognition to the vital contributions of barangay officials to nation-building; and,

WHEREAS, the forging of stronger ties among all local elective officials will redound to the benefit of all those residing and doing business in the city.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 1 of Ordinance No. SP-1155, S-2002, is hereby amended, to read as follows;

"Section 1. It is hereby declared that 21 September 2011 and every year thereafter, shall be celebrated as Barangay Day in Quezon City."

SECTION 2. Section 3 of City Ordinance No. SP-1155, S-2002, is hereby amended, to read as follows:

"Section 2. A Steering Committee is hereby created for this purpose, composed of the City Mayor or his representative to the Executive Body, with the President of the Liga ng moa Barangay as Chairman and the Head of the Barangay Operations Center (BOC) as Co-Chairman and other members to be appointed by the City Mayor to thresh out the details of the celebration."

SECTION 3. All other provisions of City Ordinance No. SP-1155 S-2002, not specifically amended shall remain in full force and effect.
