WHEREAS, the City Council of Quezon City has approved Ordinance No. SP-1836, S-2008 on Murch 10, 2008, entitled;

> THE USE REGULATING **ORDINANCE** "AN ELLIPTICAL AVENUE FROM **COMMONWEALTH** ROAD, BARANGAY OLD CAPITOL SITE, TO FAIRVIEW ENTRANCE CATE, BARANGAY FAIRVIEW, AND FOR OTHER PURPOSES"

WHEREAS, the afore-quoted ordinance was not only a laudable act of the City Council, but a timely legislative measure to address the worsening traffic situation and to minimize the consecutive road accidents, involving motorists and pedestrians, along Commonwealth Avenue which prompted the people to tag the same as the "Killer Highway";

WHEREAS, to ensure the effective and strict enforcement of Ordinance No. SP-1836, S-2008 and to compet the undisciplined motorists to observe the required speed limit in Commonwealth Avenue, there is an imperative need to amend the said ordinance to incorporate the penalty clause;

WHEREAS, the Quezon City Government is vested with police power to regulate all public roads and highways within its jurisdiction and to impose appropriate fines.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 1 of Ordinance No. SP-1836, S-2008 is hereby amended to read as follows:

"SECTION 1. The speed limit of motor vehicles traversing along Commonwealth Avenue, Quezon City are the following:

- a. Public Utility Vehicle (PUV) Sixty Kilometers per hour (60 kph)
- b. Private Vehicles Seventy Kilometers per hour (70kph)"

SECTION 2. A new section of Ordinance No. SP-1836, S-2008 is hereby incorporated to read as follows:

"SECTION 10. Any person or persons found to be violating the provisions of this ordinance shall be penalized as follows:

First Offense:

Fine of One Thousand Two Hundred Pesos (P1,200.00) or imprisonment of Three (3) Months;

Second Offense:

Pine of Two Thousand Pesos (P2,000.00) or imprisonment of Six (6) Months: and

Third Offense:

Fine of Three Thousand Pesos (P3,000.000) or imprisonment of One (1) year, or both such fine and imprisonment at the discretion of the court."

SECTION 3. The Effectivity Clause of Ordinance No. 1836, S-2008 inadvertently denominated as Section 3 shall now become Section 11.

SECTION 4. This ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
