BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 105, Article XVII of Ordinance No. NC-128, S-89, otherwise known as the Quezon City Traffic Code, is hereby amended to read as follows:

SECTION 105. All fines imposed for violations of the provisions of this Ordinance shall accrue to the General Fund of the Quezon City Government with fifty percent (50%) thereof being placed in trust under the Police and Traffic Enforcement Incentive Program.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
SESSION ASSEMBLED:

SECTION 1. Section 1 of City Ordinance No. NC-208, S-91  
is hereby amended to read, thus:

"Section 1. Financial Assistance is hereby autho-  
rized and granted to the Sergeant-At-Arms of the  
City Council, Quezon City, Police Capt. Elmo San  
Diego and his four (4) Deputy Sergeant-At-Arms,  
P/Sgt. Artemio Hipolito, P/Cpl. Cecilio Marcelo,  
Pfc. Walfredo Olabre and Pfc. Henry Mancucang, all  
of the Central Police District, at THREE HUNDRED PESOS  
(P300.00) and ONE HUNDRED PESOS (P100.00) each per  
session of the City Council respectively, for a  
maximum of ~~eight~~ (8) sessions actually attended per  
month."

SECTION 2. Section 2 of City Ordinance No. NC-208, S-91  
is hereby amended to read, thus:

"Section 2. The amount of SIXTY FOUR THOUSAND EIGHT  
HUNDRED PESOS (P64,800.00) or so much thereof as maybe  
necessary to cover the payment of the financial assist-  
ance authorized and granted under Section 1 hereof  
covering the period from January 1 to December 31, 1991,  
is hereby appropriated from any available funds in the  
City Treasury."

SECTION 3. This Ordinance shall take effect upon its  
approval.
