Be it ordained by the City Council of Quezon City in session assembled:

Section 1. The 1990 Annual Budget of Quezon City approved under Ordinance No. NC-127, S-99 is hereby amended such that development projects under the Infrastructure Fund amounting to One Hundred Forty-Four Million Four Hundred Forty-Seven Thousand Pesos (P144,447,000.00) shall be placed under the sole and direct supervision of the City Mayor. The City Budget Officer shalk make the necessary adjustments in the Budget documents to carry out the intent of this Ordinance.

Section 2. There is hereby transferred from the General Fund to the Infrastructure Fund the sum of Eighty Million One Hundred Eleven Thousand Seventy-One Pesos (P80,111,071.00) to augment the fund certified as available for appropriation by the City Treasurer under the Infrastructure Fund.

Section 3. Section 2 of Ordinance No. NC-127, S-89 is hereby amended to read as follows:

SEC. 2. There are hereby appropriated from the General Fund the sum of One_Billion One Hundred Sixty-Three Million Six Hundred Thirty-Three Thousand Seven Hundred Ten Pesos (P1,163,633,710.00) and from the Infrastructure Fund the sum of One Hundred Thirty-Three Mil-Lion Five Hundred Eight Thousand Seventy-One Pesos (P133,508,071.00), or so much thereof as may be necessary, to be made available to cover the expenditures provided for in Section One hereof, the sums to be taken from the estimates of revenues certified as available for appropriation by the City Treasurer as contained in the budget document and from the General to the transfer of fund from the General to the Infrastructure Fund".

Section 4. This Ordinance shall take effect as of January 1, 1990.
