ORDINANCE

APPROPRIATING THE SUM OF TWELVE MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (P12,750,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND AND INFRA-STRUCTURE FUND UNDER THE 1990 CITY BUDGET (ORDINANCE NO. 127, S-89) TO BE MADE AVAILABLE FOR THE MID-YEAR BONUS OF THE QUEZON CITY GOVERNMENT EMPLOYEES.

WHEREAS, the spirit of expectation is so great that at this time of the year the Quezon City government employees are jubilant of the financial benefit about to be extended by the City Administration;

WHEREAS, aware of the financial problem that families may encounter in the forthcoming opening of school classes, it is of utmost consideration that there shall be an immediate solution to the problem;

NOW, THEREFORE,

Be it ordained by the Council of Quezon City in session assembled;

SECTION 1. There is hereby appropriated the sum of Twelve Million Seven Hundred Fifty Thousand Pesos (P12,750,000.00) or so much thereof as may be necessary to be made available for the mid-year bonus of the Quezon City Government employees to be taken from the unappropriated balance under 1990 City Budget (Ordinance No. 127, S-89) broken down as follows:

₱12 Million	- from the general fund
₱750,000.00	- from the Infrastructure fund
