ORDINANCE

APPROVING SUPPLEMENTAL BUDGET NO. 3 UNDER THE GENERAL FUND AND SUPPLEMENTAL BUDGET NO. 2 UNDER THE INFRASTRUCTURE FUND FOR THE CALENDAR YEAR 1990 WHICH IMPLEMENT THE PROVISIONS OF ORDINANCE NO. NC-143, S-90, PLACING UNDER THE SOLE AND DIRECT SUPERVISION OF THE CITY MAYOR DEVELOPMENTAL PROJECTS AND TRANSFERRING THE SUM OF SEVENTY-NINE MILLION ONE HUNDRED ELEVEN THOUSAND AND SEVENTY-ONE PESOS (P79,111,071.00) FROM THE GENERAL FUND TO THE INFRASTRUCTURE FUND AND RE-APPROPRIATING ONE MILLION PESOS (P1,000,000.00) TO THE OFFICE OF THE CITY COUNCIL UNDER THE ACCOUNT OF PUBLIC ASSISTANCE/ SOCIAL AMELIORATION FUND.

Be it ordained by the City Council of Quezon City in session assembled:

Section 1.- Supplemental Budget No. 3 under the General Fund and Supplemental Budget No. 2, under the Infrastructure Fund for the Calendar Year 1990 which implement the provisions of Ordinance No. NC-143, S-90, placing under the sole and direct supervision of the City Mayor developmental projects and transferring the sum of Seventy-Nine Million One Hundred Eleven Thousand and Seventy-One Pesos (P79,111,071.00)

from the General Fund to Infrastructure Fund are hereby approved. The budget document containing the specific provisions of Supplemental Budget No. 3 (General Fund) and Supplemental Budget No. 2 (Infrastructure Fund) is hereby made an integral part of this Ordinance, with the amendment as follows: On page 13, line 3 (repair and servicing of motor vehicles - ₱2,750,000.00 is hereby reduced to One Million Seven Hundred Fifty Thousand Pesos (₱1,750,000.00). The amount of One Million Pesos (₱1,000,000.00) is hereby re-appropriated to the Office of the City Council under the account of Public Assistance/Social Amelioration Fund.

Section 2. This Ordinance shall take effect upon its approval.
