CREATING ONE (1) NEW DIRISION IN THE CITY BUDGET
OFFICE AND FOURTEEN (14) ADDITIONAL POSITIONS TO
ENABLE TO CARRY OUT ITS FUNCTIONS; AND AFPROFRIATING THE AMOUNT OF TWO HUNDRED SEVENTY-SEVEN
THOUSAND TWO HUNDRED EIGHTY-FIVE PESOS
(2277,285.00) OUT OF ANY AVAILABLE FUNDS IN THE
CITY TREASURY FOR THE PURPOSE.

WHEREAS, there is an urgent need to create one (1) new division in the City Budget Office, including fourteen (14) additional positions, that will conduct research and tabulate statistical data relevant to budgeting;

WHEREAS, the new division and additional positions herein mentioned are made imperative by the manifold increase in the volume of work in the City Budget Office and the more complex budgetary problems it has to cope with as a consequence of the increase of its City Budget from P300 Million to P1.29 Billion;

WHEREAS, the creation of the said new division and additional positions is in accordance with the provisions of Section II, Rule X of the "Rules and Regulations", implementing the Local Government Code and Circular No. 36 issued by the Joint Commission on Local Government which implements the standardization of salaries and position classifications prescribed in Republic Act Mo. 6758;

WHEREAS, the said new division and additional positions will immensely enhance the economy. efficiency and effectiveness of the Quezon City Government;

NOW, THEREFORE,

Be it ordained by the City Council of Queson City in session assembled:

SECTION 1. There is hereby created in the City Budget Office one (1) new division to be named Research and Statistics Division, and fourteen (14) additional positions, the corresponding position titles, grades/levels and salaries of which are hereunder emmerated as follows:

SECTION 2. The organizational structure of the new division as well as the duties, functions and responsibilities thereof are illustrated and defined in the supporting documents hereof consisting of eight (8) pages, the functions of the City Budget Office, statement of duties of the new division and the job description of each of the fourteen (14) additional positions to be created which are all attached and made integral parts hereof.

SECTION 3. The amount of Two Hundred Seventy-Seven Thousand Two Hundred Eighty-Five Pesos (P277.285.00) necessary for this purpose is hereby appropriated out of any available funds in the City Treasury which amount shall be included from year to year in the City Budget.
