ORDINANCE

UPGRADING THE SOCIAL WELFARE SERVICES DIVISION TO A DEPARTMENT TO BE KNOWN AS THE SOCIAL SERVICES DEVELOPMENT DEPARTMENT PROVIDING FOR ITS FUNCTIONS, AND APPROPRIATING THE AMOUNT OF ELEVEN MILLION FOUR HUNDRED FIFTY-EIGHT THOUSAND AND TWENTY PESOS (P11,458,020.00) OUT OF ANY AVAILABLE FUNDS IN THE CITY TREASURY TO COVER THE FUNDING REQUIREMENTS THEREOF.

WHEREAS, in 1954 the Social Welfare Services Division originated as a local branch of the Social Welfare Administration (now the Department of Social Welfare) and relied on the latter for technical assistance and coordination for the dissemination of social services;

WHEREAS, in 1957 the operational expenses and salaries of the office personnel was wholly funded by the Quezon City Government;

WHEREAS, in 1972 the Social Welfare Services Division adopted a program aimed at self-sufficiency and socio-economic upliftment wherein social welfare now encompasses a wider range of services catering to more disadvantaged groups;

WHEREAS, the services include Family Enrichment Programs, Community Welfare Programs, the Livelihood Programs, the Molave Youth Home and the Reception and Action Center for Youth Offenders and mendicants;

WHEREAS, an equally important function of the Division is the establishment of linkages with both government and non-governmental welfare agencies and civic groups, as well as make representations for the City Mayor with such agencies and groups as to the social welfare needs of the City;

WHEREAS, the growth of the Social Welfare entity from branch unit of the Social Welfare Administration to a section under the local government to a Department is reflective of the expanding needs of the City;

WHEREAS, this broadened concept of social welfare necessitates the upgrading and reclassification of the Social Welfare Services Division to a Department pursuant to Administrative Order No. 24, series of 1983 of the Department of Social Services for the localization of said office;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. The Social Welfare Services Division is hereby upgraded into a department to be known as the Social Services Development Department whose organizational structure, duties, functions, responsibilities and salaries are provided in the attached supporting documents consisting of twenty (20) pages, marked as Annex "A".

SECTION 2. There is hereby appropriated the amount of Eleven Million Four Hundred Fifty-Eight Thousand and Twenty Pesos (P11,458,020.00) or so much as maybe necessary out of any available funds in the City Treasury to cover the funding requirements of this Ordinance.

SECTION 3. This Ordinance shall take effect upon its approval subject to availability of funds.
