ORDINANCE
GIVING CASH REWARD TO ANY PERSON OR PERSONS WHO SHALL PROVIDE
INFORMATION CAUSING THE ARREST AND THE FILING OF THE COMPLAINT
OR INFORMATION WITH THE PROPER COURT OF ANY PERSON OR PERSONS
FOR ANY OF THE ACTS DEFINED AND PENALIZED UNDER REPUBLIC ACT
NO. 6425 OTHERWISE KNOWN AS THE DANGEROUS DRUGS ACT OF 1972
SUBJECT TO THE IMPLEMENTING GUIDELINES FORMULATED BY THE
QUEZON CITY ANTI-DRUG ABUSE COUNCIL (QCADAC), THE OFFICE OF
THE CITY PROSECUTOR AND THE OFFICE OF THE CITY TREASURER AND
APPROPRIATING ONE MILLION PESOS (\$1,000,000.00) FOR THE
PURPOSE.

WHEREAS, abuse of dangerous drugs affects the brain and the nervous system;

WHEREAS, scientific research finds drug addict a living dead;

WHEREAS, drug abuse poses serious and imminent danger not only to the life and limb of the abuser himself but also to the members of his family, neighbors and people at large;

WHEREAS, drug abuse which is a crime in itself begets another crime ranging from theft, robbery, prostitution, abortion, murder, parricide and other henious crime;

WHEREAS, drug abuse which is a menace sweeping all over the land erodes the moral and saps the physical strength of our people and the resources of our nation in the campaign for its eradication;

WHEREAS, government efforts alone will not win the war against drug menace without the involvement and participation of the citizenry;

WHEREAS, this measure seeks to involve the citizenry particularly, the mass of unemployed in our City by giving cash incentives and anable them to earn a living and others to augment their income at the same time rendering service to the people;

NOW, THEREFORE,

Be it enacted by the City Council of Quezon City in session as membled:

SECTION 1. There is hereby provided cash reward to any person or persons including those employed in any branch of

the government service who shall provide information causing the arrest and the filing of complaint or information with the proper court, of any person or persons for any of the acts defined and penalized under Republic Act No. 6425 otherwise known as the Dangerous Drugs Act of 1972.

SECTION 2. The amount of the cash reward provided in the preceding section shall be subject to the implementing guidelines formulated by the Quezon City Anti-Drug Abuse Council (QCADAC), the Office of the City Prosecutor and the City Treasurer's Office.

SECTION 3. No reward shall be given where the person or persons arrested, after having been certified by competent physician as drug dependent, shall voluntarily submit for confirement, treatment and rehabilitation in a center, or to the parent, guardian or relative with the approval of the Board created under Article VIII, Sec. 35 of Republic Act No. 6425; or where there is criminal prosecution or proceedings but before final judgment, the court ordered the commitment of the accused to a center or to parent, guardian or relative for treatment and rehabilitation.

SECTION 4. There is hereby appropriated from any available fund of the City Treasury the initial fund of One Million Pesos (\$1,000,000.00) to carry out the objectives of this Ordinance.

SECTION 5. This Ordinance shall take effect upon approval. ENACTED December 3, 1990.
