WHEREAS, the present clothing allowance granted to all employees years ago in the amount of Six Hundred Pesos(\$\mathbb{P}600.00)\$, is no longer realistic as the prices of all prime commodities has gone up including clothing materials as well as fees for made to order charges;

WHEREAS, the amount of One Thousand Two Hundred Peses (\$1,200.00) proposed increase for clothing allowance is just enough to purchase four (4) new uniforms to meet the prescribe uniform days for one week (one uniform per day) including the cost of made to order materials;

WHEREAS, realizing the need to wear uniform in the prescribed days period as strictly being enforced by our management and considering that the present clothing allowance of Six Hundred Pesos (\$600.00) could no longer meet the spiraling cost of materials;

NOW, THEREFORE,

Be it enacted by the City Council of Quezon City in session assembled:

SECTION 1. The clothing allowance of Quezon City Hall employees is hereby increased from Six Hundred Posos (\$600.00) to One Thousand Two HundredPesos (\$1,200.00) subject to the exemption from Memorandum Circular No. 52 issued by the President.

SECTION 2. There is hereby appropriated the necessary funds to cover the increase provided for under Section One hereof.
