ORDINANCE

APPROPRIATING THE AMOUNT OF ONE MILLION FIFTY THOUSAND PESOS (\$4,050,000.00) OUT OF ANY AVAILABLE FUNDS OF THE CITY TREASURY TO BE MADE AVAILABLE AS FINANCIAL ASSISTANCE TO THE TYPHOON VICTIMS IN THE VISAYAS AND MINDANAO RESULTING FROM FURY AND DEVASTATION CAUSED BY TYPHOSN RUPING ON NOVEMBER 8, 1990.

WHEREAS, on Nevember, 1990, a strong typhose codonaned Ruping swept through the Visayes and Mindenao, leaving is its wake unteld sufferings to the inhabitants of said area and extensive damage to properties;

WHEREAS, in order to mitigate the effects of said calamity and generate the rehabilitation of said area, the President of the Philippines had doclared several previnces in the Visayas and Mindanao, which stood in the path of said typhoen, under a state of calamity, and had called on all agencies of the government and the private sector to extend assistance to the victims thereof;

WHEREAS, in the spirit of brotherhood and humanitarian concern, there is a mood for Queson City to extend financial assistance to said typhoon victims in the Visayas and Mindanae and contribute, in a manner, to the rehabilitation of said area;

WHEREAS, the sufferings of the people in the Visayas and Mindanao resulting from said typheon cannot be treated in isolation from the rest of the country;

NOWS THEREFORE,

Be it ordained by the City Council of Queson City in session assembled:

Section 1. There is hereby appropriated out of any available funds of the City Treasury the amount of GNE MILLION FIFTY THOUSAND PROCE (P1.050,000.00) to be made available as financial assistance to the typhoen victims in the Visayas and Mindanao resulting from the occurence of typheon Ruping on Nevember, 1990.

Section 2. The City Mayor is hereby authorized to determine the amount which shall be extended, out of the funds appropriated under Section 1 hereof, to the provinces, cities and municipalities which were affected by said typhoon, and issue the necessary guidelines relative to the disbursement of said funds for the purpose aforecited; Provided, however, that the members of the City Council who would like to join the City Mayor or any other government official may officially accompany the delivery of the checks to the intended beneficiaries.

Section 3. This Ordinance shall take effect immediately upon its approval.
