APPROVING SUPPLEMENTAL BUDGET NO. 7 UNDER THE
GENERAL FUND AND SUPPLEMENTAL BUDGET NO. 6

UNDER THE INFRASTRUCTURE FUND FOR CALENDAR YEAR
1990 INVOLVING THE SUM OF SIX MILLION EIGHT
HUNDRED THIRTY-FIVE THOUSAND TWO HUNDRED FESOS
(P6,835,200.00), EIGHT MILLION FIVE HUNDRED
SEVENTY NINE THOUSAND FIVE HUNDRED TWENTY PESOS
(P8,579,520.00), RESPECTIVELY, AND PROVIDING
FUNDS FOR THE PURPOSE.

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. Supplemental Budget No. 7 under the General Fund and Supplemental Budget No. 6 under the Infrastructure Fund for Calendar Year 1990 to cover prior years obligations and current year expenses of the various offices of the City Government are hereby approved. The documents containing the specific items of expenditures are hereby made as integral parts of this Ordinance.

SECTION 2. There is hereby appropriated from the General Fund the sum of Six Million Eight Hundred Thirty Five Thousand Two Hundred



Pesos (\$6,835,200.00) and Infrastructure Fund the sum of Eight Million Five hundred Seventy Nine Thousand Five Hundred Twenty Pesos (#8,579,520.00) to cover the obligations and expenditures provided for in Section One hereof, the sum to be taken from the amount certified as available for appropriation by the City Treasurer which are made as integral parts of this Ordinance.

SECTION 3. This Ordinance shall take effect upon its approval.
