ORDINANCE

APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY
GOVERNMENT FOR CALENDAR TEAR 1994 IN THE TOTAL
AMOUNT OF ONE BILLION FOUR HUNDRED THIRTY-FIVE
MILLION: ONE HUNDRED NINETY-FOUR THOUSAND NINE
HUNDRED TWENTY-FIVE PESOS (\$1,435,194,925.00) COVERING THE VARIOUS EXPENDITURES OF THE CITY
GOVERNMENT FOR 1991, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

Be it ordained by the City Council of Queson City in session assembled:

SECTION 1. The annual budget of the Quezon City Government for Calendar Year 1991 in the total amount of ONE BILLION FOUR HUNDRED THIRTY-FIVE MILLION ONE HUNDRED NINETY-FOUR THOUSAND NINE HUNDRED TWENTY-FIVE PESOS (\$1,435,194,925.00) covering the various expenditures of the City Government for 1991 is hereby approved subject to the provisos and conditions contained in Annex "A" hereof.

The budget documents are hereby made as integral parts of this Ordinance.

SECTION 2. There is hereby appropriated from the General Fund the sum of ONE BILLION THREE HUNDRED SEVENTY TWO MILLION NINE HUNDRED THERTY-FIVE PESOS (P1.372.935.925.00) and from the Infrastructure Fund the sum of SIXTY-TWO MILLION TWO HUNDRED FIFTY-NINE THOUSAND PESOS (P62.259.000.00) or so much thereof as may be necessary, to be made avail-

able to cover the expenditures provided for in Section One hereof, the sums to be taken from the estimates of revenues certified as available for appropriations by the City Treasurer as contained in the budget documents.

SECTION 3. This Ordinance shall take effect on January 1, 1991.
