WHEREAS, the expenses for the maintenance and operation of the Quezon Memorial Circle are defrayed by collections arising from rentals, fees, fundraising activities and other charges;

WHEREAS, a portion of the Quezon Memorial Circle has been declared a National Shrine, while the remaining portion designated as open spaces and public parks, which have provided Quezon City residents with wholesome recreational facilities and a healthy environment conducive to the rejuvenation of the spirit;

WHEREAS, to achieve the purpose for which the Circle has been enshrined and envisioned, there is a need to further develop and improve the same, and have it maintaned, managed and operated by competent persons or entities;

WHEREAS, the Quezon City Parks Development Foundation. Inc. (QCPDFI), thru a Tri-Partite-Memorandum of Agreement end ted by and among the National Historical Institute, National Parks Development Committee, and the City Government, has been designated to carry out the Master Plan for the development, improvement and administration of the Circle;

WHEREAS, the City Government, in turn, has executed a Memorandum of Agreement with QCPDFI, whereby the latter has b designated as the implementing arm for said development and improvement, which has been ratified by the City Council;

WHEREAS, under Section 36 of the Local Government Code, the City Government, thru its local chief executive, and with the concurrence of the Sanggunian concerned, may provide financial assistance to non-governmental organizations for socially-oriented, environmental or cultural projects implemented its territorial jurisdiction;

whereas, the QCPDFI, being a non-governmental organization, and designated as implementing carmed for the development of the Circle, is qualified to receive ssistance of inancial or owner wise, in accordance with the armanural tree code rolessional

WHEREAS, in order to faithfully execute its contract with the City Government as such implementor, the QCPDFI needs all the resources and income generated from collection of rentals fees and other charges, to be used exclusively for the development, maintenance and operation of the Circle;

BE IT ORD INED BY THE CITY COUNCIL OF QUEZON CITY IN SESSEMBLED:

SECTION 1. To authorize the Mayor of Quezon City to promain financial grant to the QCPDFI, consisting of all collections is from the operation of the Circle, such as, but not limited to, rentals, fees and other charges.

SECTION 2. To allow the Foundation to allocate the abovesaid collections to be used exclusively for the purpose of deval ment and improvement of the Circle, and to account all disburse subject to existing rules and regulations, and audit by the City Auditor.

SECTION 3. This Ordinance shall take effect upon its approval.
