SECTION 2. The City Budget Officer shall coordinate with the Office of the City Mayor and the Office of the City Treasurer (Accounting Divi-sion) to effect the augmentation authorized under Section 1 hereof, a copy of which shall be furnished to all the members of the City Council.

SECTION 3. This Ordinance shall take effect upon its approval.
