ORDINANCE
SETTING THE DEADLINE FOR THOSE TRICYCLE FRANCHISES EXTENDED BY
VIRTUE OF ORDINANCE NO. SP-48, S-93 TO REGISTER AND/OR CONFIRM
THEIR RESPECTIVE FRANCHISES WITH THE TRICYCLE REGULATION UNIT.

WHEREAS, there is an urgent need for an inventory of all existing tricycle franchises to set the proper Route Measure Capacity of all tricycle associations plying the streets of Quezon City;

WHEREAS, in order to indicate the Route Measure Capacity in the earliest possible time, there is a need to set a deadline in the registration and/or confirmation of all existing tricycle franchises with the Tricycle Regulation Unit;

WHEREAS, in-order to better serve the riding public and the residents of Quezen City, the Sangguniang Panlungsed as the Legislative body is mandated to enact reasonable and wholesome laws, preserve the comfort and convenience of its inhabitants (Section 16 Local Government Code of 1991);

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All tricycle franchises extended by virtue of Ordinance Nc. SP-48, S-93 are required to register and/or confirm their respective tricycle units until May 15, 1993 with the Tricycle Regulation Unit.

SECTION 2. Failure to comply with this requirement shall mean lack of interest on the part of the franchise holder to continue the operation of a motorized tricycles for hire and shall lead to the cancellation of their respective franchises.

SECTION 3. The Tricycle Regulation Unit is horeby directed to notify all Tricycle Operators and Drivers Associations operating and located in Quezon City to comply with this requirement.

SECTION 4. Ordinance No. SP-48, 8-93 is ammended accordingly SECTION 5. This Ordinance shall take effect immediately upon its approval.
