WHEREAS, a fire of unknown origin broke out in Bukidnon Street, Barangay Magsaysay, Quezon City on March 2, 1993 affecting thirty-two (32) families as reported by the Social Services Development Department;

WHEREAS, fourteen (14) families of the fire victims are house owners while eighteen are house renters;

WHEREAS, the amount of Two Thousand Pesos (P2,000.00) for each house owner and One Thousand Pesos (P1,000.00) for each house renter in the form of material aid will greatly alleviate the suffering of these fire victims;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The amount of Forty-Six Thousand Pesos (P46,000.00) or so much thereof as may be necessary is hereby allocated from the Calamity Fund of the City to defray the cost of the material assistance to the thirty-two (32) families that were affected by the March 2, 1993 fire incident in Bukidnon Street, Barangay Ramon Magsaysay, Quezon City

SECTION 2. This Ordinance shall take effect upon its approval.
