BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SES-SION ASSEMBLED:

SECTION 1. The sum of Eighty-Nine Thousand Peses (#89,000.00), er so much thereof as may be necessary is hereby allocated from the Calamity Fund of the City to defray the cost of material assistance to the Fifty-Six (56) victims, thirty-three (33) house owners and twenty-three (23) house reners, of the fire that affected their houses in Barangay Balingasa, Quezon City on Maron 10, 1993.

SECTION 2. The Office of the City Engineer and the Office of the Social Services Development Department are hereby enjoined to coordinate as facilitators in the enderly implementation hereo.
