Ordinance No. SP-69, S-93

ORDINANCE

ALLOCATING EIGHTY-NINE THOUSAND PESOS (P89,000.00), OR SO MUCH THEREOF AS MAY BE NECESSARY, TO DEFRAY THE COST OF MATERIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT AFFECTED FIFTY-SIX (56) FAMILIES IN GALINO STREET, CORNER 11TH AVENUE, BARANGAY BALINGASA, QUEZON CITY ON MARCH 10, 1993, THE AMOUNT TO BE TAKEN FROM THE CALAMITY FUND OF THE CITY.

WHEREAS, a fire occurred at Galino Street, corner 11th Avenue, Barangay Balingasa, Quezon City on March 10, 1993 affecting Fifty-Six (56) families, thirty-three (33) house owners and twenty-three (23) renters, as reported by the Social Services Development Department;

WHEREAS, these unfortunate fire victims need the assistance of the City Government in form of material aid such as building materials for the reconstruction of their houses, food, clothing, etc., in the amount of Two Thousand Pesos (P2,000.00) for each house owner and another One Thousand Pesos (P1,000.00) for each house renter;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The sum of Eighty-Nine Thousand Pesos (P89,000.00), or so much thereof as may be necessary is hereby allocated from the Calamity Fund of the City to defray the cost of material assistance to the Fifty-Six (56) victims, thirty-three (33) house owners and twenty-three (23) house renters, of the fire that affected their houses in Barangay Balingasa, Quezon City on March 10, 1993.

SECTION 2. The Office of the City Engineer and the Office of the Social Services Development Department are hereby enjoined to coordinate as facilitators in the orderly implementation hereof.

SECTION 3. This Ordinance shall take effect upon its approval.
