

Ordinance No. SP-70, S-93

ORDINANCE

GRANTING FINANCIAL ASSISTANCE TO THE FAMILIES OF THE LATE EX-COUNCILORS ISIDRO R. SALUDES AND SATURNINO BERMUDEZ WHO DIED ON DECEMBER 30, 1992 AND JANUARY 8, 1993 RESPECTIVELY, IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) EACH FOR A TOTAL OF ONE HUNDRED THOUSAND PESOS (P100,000.00), FUNDS TO BE CHARGED AGAINST ITEM "OTHER SERVICES" OF THE BUDGET OF THE CITY COUNCIL.

WHEREAS, Ex-Councilor Isidro R. Saludes has served the government in various positions from Municipal Judge up to City Councilor of Quezon City from February 2, 1988 to June 30, 1992;

WHEREAS, Ex-Councilor Saturnino Bermudez has served the City Government in various positions ending his career as City Councilor of Quezon City from January 1, 1964 to September 9, 1971;

WHEREAS, Ex-Councilor Saludes died on December 30, 1992 and Ex-Councilor Bermudez died on January 8, 1993;

WHEREAS, the City Government would like to assist the families in settling various obligations brought about by their untimely death;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. A financial assistance is hereby granted to the families of the late Ex-Councilors Isidro R. Saludes and Saturnino Bermudez in the amount of Fifty Thousand Pesos (P50,000.00) each.

SECTION 2. The One Hundred Thousand Pesos (P100,000.00) financial assistance will be charged against the item "OTHER SERVICES" in the Budget of the City Council.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
