ORDINANCE EXTENDING MATERIAL ASSISTANCE TO THE SEVENTEEN (17) FAMILIES WHO WERE VICTIMS OF THE FIRE THAT OCCURED LAST JANUARY 27. 1993 AT PUROK I, UNIT 2, KAUNLARAN STREET, BARANGAY COMMON-WEALTH, QUEZON CITY IN THE AMOUNT OF ONE THOUSAND PESOS (₱1,000.00) PER FAMILY OWNER AND FIVE HUNDRED PESOS (₱500.00) PER FAMILY RENTER AND APPROPRIATING THE AMOUNT OF THIRTEEN THOUSAND FIVE HUNDRED PESOS (\$13,500.00) THEREFOR.

> WHEREAS, a fire occured in the blighted area of District II and affected indigent families thereon as per submitted Report of Findings by Social Services Development Department (SSDD) of Quezon City who are expectant of assistance from the City Government for their rehabilitation;

> WHEREAS, it has been the established policy of the Quezon City Administration to extend assistance to City residents who are victims of fire and similar calamities;

NOW, THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, that:

SECTION 1. The amount of One Thousand Pesos (\$1,000.00) per family owner and Five Hundred Pesos (\$500.00) per family renter is hereby extended to the said Seventeen (17) families who were victims of the fire that broke out at Purok I, Unit 2, Kaunlaran Street, Barangay Commonwealth, Quezon City.

SECTION 2. The amount necessary shall be made available to cover the material assistance provided for in Section One (1) hereof, which amount shall be taken from the calamity of Emergency Fund or from any available funds from the City Treasury of the 'ity Government.

SECTION 3. The material assistance for the rehabilitation of the fire victims provided for by this Ordinance shall be released immediately to the Social Pervices Development Department (SSDD) wh .h shall take charge in taking the necessary actions to facilitate the immediate release of the assistance to said fire victims Crein voordination officials of Barangay commonweal
