WHEREAS, the MOWELFUND has a social welfare program aimed to help the poor and underpaid movie workers, who work on a per-picture basis such as stuntmen, bit player, technician, make-up artist, cameraman, checkers, props men and other film crew who do not have private insurance coverage and SSS benefits;

WHEREAS, the program include medical, surgical, death aid, continuing medical benefit, free clinic day, livelihood and housing program;

WHEREAS, to show the support of the Quezon City government, it intends to increase by One Peso (P1.00) the admission fees in cinemas in the City, the proceeds thereof to be donated to Movie Welfare Fund (MOWELFUND).

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission fees in all cinemas or movie houses in Quezon City are hereby increased by One Peso (P1.00) from July 1 to 31, 2008.


SECTION 2. The proceeds of the One Peso prescribed in Section 1 hereof shall be donated in connection with MOWELFUND Development Project.


