ORDINANCE NO. SP-**1837**, S-2008
(PO2008-52)

AN ORDINANCE IMPOSING A ONE PESO (P1.00) INCREASE TO ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY COVERING THE PERIOD FROM JUNE 1 TO 30, 2008, THE PROCEED THEREOF TO BE DONATED TO THE BOY SCOUTS OF THE PHILIPPINES, QUEZON CITY CHAPTER TO SUPPORT ITS PORGRAMS AND ACTIVITIES.

WHEREAS, the Boy Scouts of the Philippines, Quezon City Chapter, a public corporation duly organized and existing pursuant to Commonwealth Act No. 111, as amended by Presidential Decree No. 460 and Republic Act No. 7278, is authorized to "xxx accept and receive funds, real and personal property by gift, devise, bequest or other means, and to conduct fund raising activities xxx";

WHEREAS, activities and services conducted by the BSP-Quezon City Chapter are geared towards the promotion of moral, spiritual and physical well-being of the youth, development of sports, skills training and livelihood, promotion of environmental and waste management program and community development of the city;

WHEREAS, in commemoration of the 60th Diamond Jubilee, the BSP-Quezon City Chapter will be hosting the 2nd NCR-Central Luzon Joint Regional Jamboree on April 14-18, 2008 and the 12th Quezon City-Chiba City, Japan Boy Scout Exchange Program on December, 2008;

WHEREAS, to show the support of the Quezon City government, it intends to increase the admission fees in all cinemas in Quezon City by One Peso (P1.00) and the proceeds thereof shall be donated to the Boy Scouts of the Philippines, Quezon City Chapter.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission fees in all cinemas/movie houses in Quezon City are hereby increased by One Peso (P1.00) from June 1 to 30, 2008.

SECTION 2. The proceeds of admission fee increase as prescribed in Section 1 hereof shall be donated to the Boy Scouts of the Philippines, Quezon City Chapter to support its program and activities.









SECTION 3. This Ordinance shall take effect upon its approval




