WHEREAS, the Quezon City government exercises its mandate pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Quezon City Public Schools has no existing standard school gate;

WHEREAS, there is a need to provide for an identified, unification school gate for the Quezon City Public Schools.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,

Section 1. This ordinance shall be known as the "School Gate Arch Ordinance".




Section 2. The Office of the City Engineer is hereby mandated to make the necessary plans and cost estimates for the construction of the said school gate.

Section 3. Copies of such plans and cost estimates shall be submitted to the Office of the City Mayor, the Office of the City Budget Officer and the Office of the City Treasurer.

Section 4. After receipt of said plans and cost estimates, the City Budget Officer shall allocate from the existing infrastructure or other budget of the City the amount necessary therefore or include the costs therefore in the City's annual or supplemental budgetary appropriations for the year immediately succeeding the date of approval of its ordinance.

Section 5. Thereafter, the City Engineer shall immediately effect the construction of the said school gate arch in accordance with existing rules and regulations.

Section 6. This ordinance shall take effect immediately upon its approval.




