## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,

Section 1. This ordinance shall be known as the "Barangay Justice Hall of Quezon City Ordinance".

Section 2. The Office of the City Engineer is hereby mandated to make the necessary plans and cost estimates for the erection of the said Barangay Public Justice Hall.

Section 3. Copies of such plans and costs estimates shall be submitted to the Office of the City Mayor, the Office of the City Budget Officer and the Office of the City Treasurer.
