
AN ORDINANCE AMENDING ORDINANCE NO. SP-1207, S-2002, PROVIDING BURIAL BENEFITS TO BARANGAY OFFICIALS REGULAR MEMBERS OF BARANGAY PUBLIC SECURITY OFFICERS (BPSO) AND THE MEMBERS OF LUPON TAGAPAMAYAPA AND APPROPRIATING THE NECESSARY FUNDS THEREFOR, SO AS TO CHANGE THE TERMS USED TO INCREASE THE RATES PRESCRIBED THEREIN.

WHEREAS, Ordinance No. SP-1207, S-2002 was enacted on December 3, 2002 and thereafter confirmed by the Quezon City Council on December 10, 2002 it has been six (6) years already from the time of its approval and still there were no further amendments made by the Quezon City Council on the same;

WHEREAS, being the backbone in delivering the basic services to their constituents, the elected barangay officials as well as the appointed Barangay Public Security Officers (BPSO) have faithfully serve without taking into consideration the adversity that often jeopardize their health and worse put at stake their very lives, hence, there is a need for the amendments as to the rate of burial assistance that may be extended to them;

WHEREAS, the increase in the rate of the burial assistance is proper and indispensable taking into consideration the higher cost of burial expenses nowadays as compared to the cost of burial expenses at the time of the passage of the said Ordinance.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED.

SECTION 1.The term "Barangay Security Development Officers" (BSDO) used in Ordinance No. SP-1207, S-2002 is hereby amended to "Barangay Public Security Officers" (BPSO).

SECTION 2. Section 2 of Ordinance No. SP-1207, S-2002 is hereby amended such that it shall be read as follow:

Section 2. Appropriation - The sum of Five Million Pesos (P5,000.000.00) in the General Fund is hereby appropriated of the purpose of defraying the cost of burial expenses of Barangay Officials, regular members of Barangay Public Security Officers (BPSO) and the member of the Lupon Tagapamayapa who died in line of service during the term of office, provided, that the burial benefit shall be according to the following rates:

SECTION 3. All existing Ordinances or parts thereof which are inconsistent with any provisions or part of this ordinance are hereby repealed and modified accordingly.

SECTION 4. If for any reason or reasons, any part of provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

SECTION 5. This Ordinance shall take effect immediately upon its approval.
