(PO2008-93)

AN ORDINANCE MANDATING THE PROVISION OF TWO (2) COMPUTER SETS WITH INTERNET CONNECTION TO BE INSTALLED IN EVERY PUBLIC LIBRARY WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY, AND APPROPRIATING THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00) TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, it is a declared policy of the State to give priority in providing access to education for the intellectual, moral development and for economic advancement of its constituency;

WHEREAS, for the fulfillment of the constitutional mandate it is necessary to help effect faster delivery of educational materials and resources to the public making information timely, organized and most importantly accessible to all;

WHEREAS, the City Council is mandated to regulate the operation of all public libraries and to ensure all necessary supplements are provided for the betterment of the services being rendered thereof;

WHEREAS, in the advent of technological advancements, accessibility to the internet would surely provide necessary tools in library user's quest for information and sufficient references and reading materials of the Main Library and in other legitimate websites;

WHEREAS, indeed such provision of internet connectivity would entice our students to active use of public libraries and would frequent the utilization thereby achieving the above mentioned purpose;

WHEREAS, at present, the Quezon City Public Library which maintains twenty (20) public libraries is experiencing difficulty in the implementation of their library system due to lack of or insufficiency of interconnectivity of computers in their library branches, hence, the urgent need for the said provision.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. It is hereby mandated that Two (2) computer sets with internet connection be installed in identified public libraries in Quezon City, and appropriating the necessary funds therefor.


SECTION 2. The amount of Two Million Pesos (P2,000,000.00) shall be appropriated, to be taken from any available funds of the City Treasury.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
