ORDINANCE NO. SP-**1877**-S-2008

AN ORDINANCE RENAMING THE PORTION OF 11TH JAMBOREE STREET FROM TIMOG AVENUE TO EDSA, BARANGAY SOUTH TRIANGLE, QUEZON CITY TO "GMA DRIVE".

WHEREAS, streets, avenues, boulevards, parks, playgrounds, historical spots and other places are so named as to signify and perpetuate the greatness and nobility of certain personage of note, or the significance of certain events;

WHEREAS, Section 13, paragraph b (2) of the Local Government Code of 1991 provide that:

The Sangguniang of highly urbanized cities and component cities whose charters prohibited their voters from voting for provincial elective officials, hereinafter referred to in this Code as independent component cities, may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction;

(2) City roads, avenues, boulevards, thoroughfares, and bridges;

WHEREAS, the recent completion of the new state of the art GMA Network Studios has added glitter in Quezon City as new prominent landmark along 11th Jamboree Street;

WHEREAS, the new state of the art GMA Network Studios will provide quality entertainment not only on the form of pre-recorded shows but live performances as well, these studios will be one of the major attraction in the City and it will attract local and foreign visitors;

WHEREAS, the said portion of the street if in fact a separate road from 11th Jamboree, which is proper and logical to change the name of this street;

WHEREAS, in order to extol the name of place, it is most benefiting to use GMA Drive on a street where motorist, local visitors and foreigners may pass to lead them to these studios and it will certainly facilitate name recall and reference to that exact address.

NOW, THEREFORE

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The portion of 11th Jamboree (from Timog Avenue to EDSA) in Barangay South Triangle, Quezon City is hereby renamed as "GMA Drive."


SECTION 2. To avoid the inconvenience that may arise in the delivery of postal matters and in guiding people accustomed to the old name, "11th Jamboree Street" shall be printed at the bottom of the signage "GMA Drive" for at least two (2) years.

SECTION 3. The Office of the President, the Congressman of the 4th District of Quezon City and Director of the Postal Services Office, as well as all agencies concerned, shall be notified of this Ordinance pursuant to Section 13, paragraph (h) of the Local Government Code of 1991.



SECTION 4. This Ordinance shall take effect fifteen (15) days after its publication of general circulation.




