(PO2007-45)

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. SP-1384, S- 2004, SO AS TO INCLUDE TATALON MARKET AS ONE OF THE EXEMPTED MARKETS FROM FRANCHISE REQUIREMENT.

WHEREAS, the City Council is aware that a considerable number of public market and slaughterhouses, notwithstanding their lack of a franchise to operate as mandated, have timely and substantially complied with the provisions of the Quezon City Market Code;

WHEREAS, the application and implementation of the Quezon City Market Code should be pursuant to the principle that those who are in substantial compliance with the law should be given a certain degree of incentive and that the law should be applied prospectively;

WHEREAS, exempting private markets/slaughterhouses from the franchise requirement under the Quezon City Market Code will in effect promote the general welfare of our beloved constituents as there will no longer be an imposition of an additional franchise tax or financial burden that the market and slaughterhouse and operators will be passing on to the consumers – our constituents.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

Section 1. Section 1 of Ordinance No. SP-1384, S-2004, is hereby amended to read as follows:
