AN ORDINANCE APPROVING THE SUBDIVISION PLAN WITH SEVENTEEN (17) LOTS OF A SOCIALIZED HOUSING PROJECT UNDER THE COMMUNITY MORTGAGE PROGRAM OF A PARCEL OF LAND CONTAINING AN AREA OF ONE THOUSAND (1,000) SOUARE METERS GROSS PROJECT AREA, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-57117 (289492) OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF BANCO FILIPINO SAVINGS AND MORTGAGE BANK LOCATED AT LOT 1096-E-1 (LRC) PSD-2668, SITIO BARIMBAO, BARANGAY TANDANG SORA, QUEZON CITY. APPLIED *FOR* THEMANILA. ASBYHOPEMETRO HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY ITS PRESIDENT MR. ROLANDO BARDILAS, AS A VARIANCE PURSUANT TO SECTION 9. RULE III OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF BATAS PAMBANSA BII ANG 220.

WHEREAS, the Quezon City Council under the Local Government Code of 1991 is empowered to approve subdivision plans for residential, commercial and industrial purposes;



WHEREAS, strict observance of the standards and requirements set by the Implementing Rules and Regulations of Batas Pambansa Bilang 220 on the submitted plan, as applied for by the Hope Homeowners Association, Inc., shows that out of 17 saleable lots there are 2 lots (11.76%) that fall below the minimum standard of 32 sq.m. Generally, this project can, therefore, be treated as a variance pursuant to Section 9, Rule III of the Implementing Standards, Rules and Regulations of Batas Pambansa Bilang 220.

WHEREAS, pursuant to Section 9, Rule III of the Implementing Rules and Regulation of Batas Pambansa Bilang 220, relative to the aforementioned ground, variances or exceptions may be granted.

The Subdivision Plan of a Socialized Housing Project under the Community Mortgage Program of a parcel of land containing an area of One Thousand (1,000) Square Meters, technically identified under Transfer Certificate of Title Numbered RT-57117 (289492) with seventeen (17) lots located at Lot 1096-E-1, (LRC) Psd-2668, Sitio Barimbao, Barangay Tandang Sora, Quezon City, Metro Manila, as applied for by the Hope Homeowners Association, Inc., represented by its President Mr. Rolando Bardilas, as a variance pursuant to Section 9, Rule III of the Implementing Rules and Regulations of Batas Pambansa Blang 220, is hereby approved.
