ORDINANCE NO. SP-**1985**S-2009

AN ORDINANCE AMENDING ORDINANCE NO. SP-1944, S-2009, IN ORDER TO CORRECT THE POSITION TITLES AND SALARY GRADES OF SOME POSITIONS CREATED UNDER THE OFFICE OF THE CITY BUILDING OFFICIAL.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. Ordinance No. SP-1944, S-2001 is hereby amended in order to correct the position titles and salary grades of some positions created under the Office of the City Building Officials, as follows;

- 1. The Salary Grade of the two (2) positions of City Government Assistant Department Head III is hereby amended from Salary Grade 25 to Salary Grade 26.*
- 2. The Position Title of four (4) positions of Assistant is hereby*


3. The Position Title of the thirteen (13) positions of Information Technology Officer II (SC-14) is hereby amended to Computer Operator IV (SG-14).

SECTION 2. This Ordinance shall take effect upon its approval.


