AN ORDINANCE AMENDING ORDINANCE NO. SP-2273, S-2014 ENTITLED, AN ORDINANCE ADOPTING THE SEAL OF GOOD HOUSEKEEPING IN ALL BARANGAYS OF QUEZON CITY.

WHEREAS, Ordinance No. SP-2273, S-2014 entitled, "An Ordinance Adopting the Seal of Good Housekeeping in All Barangays of Quezon City" was approved by the 19th Quezon City Council on February 10, 2014;

WHEREAS, on February 24 to June 19, 2015 the QCBSGH Assessment Team commenced its task to assess the 142 barangays in the City. The team was composed of the representatives from the following:

1. Office of the Vice Mayor
 2. Office of the Secretary to Sangguniang Panlungsod (OSSP)
 3. Barangay Operations Center
 4. Environment Protection and Waste Management Department (EPWMD)
 5. DILG-Quezon City Field Office
 6. City Accounting Department

 8. City Public Affairs and Information Services Office (PAISO) ✓

WHEREAS, on September 21, 2015, during the Barangay Day celebration of the city, the Dangal ng Lunsod awards were conferred to four (4) Barangays and the Huwaran sa Pamamahala were awarded to five (5) Barangays;

WHEREAS, special citations were conferred to six (6) Barangays with noteworthy performance of Barangay-Based Institutions, ten (10) Barangays with Best Practices, twenty (20) Barangays with Good Financial Housekeeping and one hundred nineteen (119) Barangays with Legislative Services Citation;

WHEREAS, during the post evaluation by the Technical Working Group yielded some issues and concerns and recommendation for the implementation of the ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. SECTION 2 (A) Gawad sa Huwarang Pamamahala Award and Section 2 (B) Dangal ng Lungsod Award (c) (1) are hereby amended to read as follows:

c). Accountable Governance

1. The opinion rendered by the City Accounting Department regarding the financial statements for the preceding year.

SECTION 2. SECTION 5 of Ordinance No. SP-2273, S-2014 is hereby amended to read as follows:

SECTION 5. ANNUAL APPROPRIATION - The amount of Ten Million Pesos (Php10,000,000.00) is hereby appropriated to be taken from any available funds of the City Mayor subject to existing accounting and auditing rules and regulations and for the following purposes, to wit: *

- a) Cash award;
- b) Operational cost of the Technical Working Group;
- c) Event and awarding ceremony;
- d) Book publication;
- e) Special citations; and
- f) Plaque.

SECTION 3. OTHER AWARDS AND CITATIONS – The following awards and citations shall be included in the awarding ceremony, book publication of the Seal of Good Housekeeping and other incentive/s as may be determined by the Technical Working Group:


- a) *Noteworthy Performance of Barangay-Based Institutions* – Barangays with the highest percentage based on the assessment form on each Barangay-Based Institution.
 - 1. Barangay Development Council
 - 2. Barangay Peace and Order Council
 - 3. Barangay Anti-Drug Abuse Council
 - 4. Barangay Ecological Waste Management Committee
 - 5. Barangay Council for the Protection of Children
 - 6. Barangay Gender and Development Focal Point System
- b) *Other Barangay Best Practices* – Barangays who garnered at least 80% average rating based on the Best Practice/Innovations Assessment tool.
- c) *Good Financial Housekeeping* – Barangays exhibiting outstanding compliance to the accounting and auditing rules through prompt submission of financial documents and compliance to the various laws on barangay annual budgeting and government procurement (RA 9184) and commendable financial practices as a solid manifestation of further uplifting transparency in governance or “Matinong Pamamahala”.
- d) *Legislative Services* – To qualify, Barangay must get at least 80% average rating in the Quezon City Barangay Legislative Services Assessment conducted by the Technical Working Group, which includes the areas of Barangay Local Legislation, Internal Rules and Procedures, Legislative Tracking and Analysis System and the Executive and Legislative Agenda (ELA). *X*

SECTION 4. EFFECTIVITY - This ordinance shall take effect immediately upon its approval.


