AN ORDINANCE APPROVING THE SUBDIVISION PLAN WITH THIRTY SEVEN (37) LOTS OF A SOCIALIZED HOUSING PROJECT UNDER THE COMMUNITY MORTGAGE PROGRAM OF A PARCEL OF LAND CONTAINING AN AREA OF TWO THOUSAND TWENTY EIGHT (2, 028.00) SQUARE METERS GROSS PROJECT AREA, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-329163 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF PINAGBUKLOD IDANG HOMEOWNERS ASSOCIATION, LOCATED AT LOT 87. FLS-2696-D. IDANG STREET ARGUARDIENTE, BARANGAY STA. MONICA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE PINAGBUKLOD IDANG HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY ITSPRESIDENT, MR. AUGUSTO CAMAÑO, IN COMPLIANCE WITH THE MINIMUM STANDARDS, RULES AND REGULATIONS OF BATAS PAMBANSA BILANG 220.

WHEREAS, the Quezon City Council under the Local Government Code of 1991 is empowered to approve subdivision plans for residential, commercial and industrial purposes;

WHEREAS, strict observance of the standards and requirements set by the Implementing Rules and Regulations of B.P. Blg. 220 on the submitted plan, as applied for by the Pinagbuklod Idang Homeowners Association, Inc., shows that out of 37 saleable lots all are in the minimum standards of 32.00 square meters. Generally, this project is in compliance with the minimum Standards, Rules and Regulations of Batas Pambansa Bilang 220.
