ORDINANCE NO. SP- **1956**, S-2009

AN ORDINANCE CONSTITUTING A ONE-WAY TRAFFIC REGULATION ALONG NUEVA VIZCAYA STREET IN BARANGAY STO. CRISTO, DISTRICT I, QUEZON CITY BETWEEN 1:00 IN THE AFTERNOON UP TO 9:00 IN THE EVENING.

WHEREAS, the Barangay Council of Barangay Sto. Cristo in the First District of Quezon City passed Resolution No. 29-B, Series of 2009, requesting the Sangguniang Panlungsod to constitute a one-way traffic regulation along the portion of Nueva Vizcaya Street between the corners of Palawan and Misamis Street between 1:00 in the afternoon up to 9:00 in the evening for the following reason;

WHEREAS, the Local Government Code of 1991 mandated the barangay council to regulate the use of streets and roads for the

WHEREAS, heavy traffic is one of the major problems that all local government units with highly urbanized areas has to confront on a day-to-day basis;

WHEREAS, in order to deal with this perennial challenge, barangays has to regulate the flow of traffic in thoroughfares within their area of jurisdiction;

WHEREAS, Barangay Sto. Cristo is experiencing heavy traffic during rush hours in arteries going to SM City North Edsa, particularly, Nueva Vizcaya Street;


WHEREAS, as provided in Section 391 (1) of the Local Government Code, it is the duty of Barangay to promote the general welfare of its inhabitants through the enactment of necessary ordinances;

WHEREAS, paragraphs (a) (4) (v) and (vi), Section 458 of Republic Act No. 7160, otherwise known as Local Government Code of 1991, vest in the Sangguniang Panlungsod the power to regulate traffic on all streets and bridges and the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. *A one-way traffic regulation is hereby constituted along the portion of Nueva Vizcaya Street between the corners of Palawan and Misamis Streets at Barangay Sto. Cristo, District I, Quezon City, between 1:00 in the afternoon up to 9:00 in the evening.*


 

SECTION 2. This Ordinance shall be published in a newspaper of general circulation within Quezon City and shall take effect fifteen (15) days following such publication.
