ORDINANCE NO. SP-1963, S-2009

*AN ORDINANCE GRANTING A FRANCHISE TO NORTH DIVERSION MARKET AND DEVELOPMENT CORPORATION FOR THE OPERATION OF A WET AND DRY MARKET LOCATED AT NO. 33 OLD SAMSON ROAD, BALINTAWAK, QUEZON CITY.*

*WHEREAS, the Quezon City Market Code of 2000 provides that all public markets/ slaughterhouses must secure a franchise from the City Council;*

*WHEREAS, under Ordinance No. SP-1271, S-2003, all markets and slaughterhouses existing prior to the effectivity of the Market Code are exempt from the regulatory requirements for franchise, except from payment of franchise tax;*

*WHEREAS, the North Diversion Market and Development Corporation, through its owner and/or operator Mr. Laureto Lacsamana, applied for a franchise to operate a private market along No. 33 Old Samson Road, Balintawak, Quezon City;*

*WHEREAS, North Diversion Market has been in existence prior to the effectivity of the Market Code of Quezon City and is therefore exempt from the regulatory requirements for franchise, except from payment of a franchise tax;*

*WHEREAS, the Market Development and Administration Department has recommended the grant of a franchise to operate a private market to the North Division Market and Development Corporation.*

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
REGULAR SESSION ASSEMBLED:


SECTION 1. A franchise is hereby granted to North Diversion Market Development Corporation, to operate a private market named "North Diversion Private Market" located at No. 33 Old Samson Road, Balintawak, Quezon City.

SECTION 2. The franchise granted herein is subject to the conditions and limitations to be imposed and as required by the Market Code of 2000, other City Ordinances and national laws.


SECTION 3. The franchise granted herein shall be for a period of three (3) years.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
