ORDINANCE NO. S-1967 S-2009

AN ORDINANCE RECLASSIFYING THE ROAD-END OF LOS ANGELES STREET, BARANGAY IMMACULATE CONCEPTION FROM ROAD LOT TO INSTITUTIONAL ZONE FOR THE PURPOSE.

Introduced by Councilors ANTONIO E. INTON, JR., JESUS MANUEL C. SUNTAY, JANET M. MALAYA, EDCEL B. LAGMAN, JR., VINCENT DG. BELMONTI, RESTITUTO B. MALAÑGEN, CONCEPCION S. MALAÑGLIN, ALEXIS GRACE R. MATIAS, VICTORINO DODOFREDO LIBAN III, WENCEROM BENEDICTO C. LAGUMBAY and JAIME F. BORRES.

WHEREAS, Republic Act No. 7150, provides that a local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, parks or square jutting within its jurisdiction;

WHEREAS, Republic Act No. 7160, also known as the Local Government Code of 1991, provides that the function of the Barangay is to "submit to the Sangguniang Panlungsod or Sangguniang Bayan such suggestions or recommendations as it may see fit for the improvement of the Barangay or for the welfare of the inhabitants thereof;

WHEREAS, at present, due to lack of open space for Barangay Immaculate Conception, the Barangay is renting a small office for the council and staff to deliberate their services to their constituents;

WHEREAS, the Barangay Council of Barangay Immaculate Conception seeks the assistance of the City Government for the site that can be constructed of their permanent home for their Barangay Hall;

WHEREAS, there is a need to reclassify the road-end of Los Angeles Street, Barangay Immaculate Conception, this City, to house the permanent Barangay Hall of the said barangay for the development and improvement of their services to its constituents and considering that the Road-end of the aforementioned street as the suitable place for their permanent office.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. Road-end of Los Angeles Street, Barangay Immaculate Conception is hereby reclassified from Road Lot to an Institutional Zone.

SECTION 2. The City Planning and Development Office shall ensure the strict implementation of this Ordinance and is hereby given plenary powers and authority to carry out the provision of this ordinance.


SECTION 3. This Ordinance shall take effect upon its approval.


