ORDINANCE NO. S -1 9 6 7 S-2009

AN ORDINANCE RECLASSIFYING THE ROAD-END OF LOS ANGELTS STREET, BARANGAY IMMACULATE CONCEPTION FROM ROAD TOT TO INSTITUTIONAL ZONE FOR THE PURPOSE.

Introduced by Councilors ANLONIO E. INTON, JR., JESUS MANUEL C. SUNTAY, JANET M. MALAYA, EDCEL B. LAGMAN, JR., VINCENT DG. BELIMONTE, RESTITUTO B. MALAÑGEN, CONCEPCION S. MALAÑGEN, ALEXIS GRACE R. MATIAS, VC TAIRE CODOFREDO LIBAN III, WENCEROM BENEL CT C. LAGUMBAY and JAIMUE, BORRES.

WHEREAS, Republic Act No. 7150, provides that a local government unit may, pursuant to an ordinance, permanently or temporary close or apenany local road, alley, parks or square Juling within its jurisdiction;

WHEREAS, Republic Act No. 7160, clso known as the fixed Government Code of 1991, provides that the function of the Barangay is a "submit to the Sangguniang Panlur good or Sangguniang Bayan such suggestions or recommendations as it may see fit for the improvement of the Barangay or for the welfare of the inhavitants thereof;

WHEREAS, at present, due to lack of open space for Barangey Immaculate Conception, the Barangey is realing a small office for the council and staff to deliberate their services to their constituents;

WHEREAS, the Barangay Council of Barangay Immacutae Conception seeks the assistance of the Lity Government for the site that were be constructed of their permanent home for their Barangay Hall;

WHEREAS, there is a need to reclassify the road-end of Los Angeles Street, Barangay Immaculate Conception, this City, to house the permanent Barangay Hall of the said barangay for the development and improvement of their services to its constituents and considering that the Road-end of the aforementioned street as the suitable place for their permanent office.

JOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

Section 1. Road-End of Los Angeles Street, Barangay Immaculate Conception is hereby reclassified from Road Lot to an Institutional Zone.

SECTION 2. The City Poinning and Development Office shall ensure the strict implementation of this Ordinance and is hereby given plenary powers and authority to carry cut the provision of this ordinance.

SECTION 3. This Crdinance shall take effect upon its approval.
