ORDINANCE NO. SP- 1972 S-2009

AN ORDINANCE DEFINING THE TERRITORIAL BOUNDARIES OF BARANGAY BALON-BATO, QUEZON CITY AND FOR OTHER PURPOSES.

Introduced by Councilors ALLAN BUTCH T. FRANCISCO, WINSTON "Winnie" T. CASTELO, RAMON P. MEDALLA, VOLTAIRE GODOFREDO L. LIBAN III, EDEN "Candy" A. MEDINA and AIKO S. MELENDEZ.

WHEREAS, Barangay Balon-Bato was created by virtue of P.D. No. 1316 which was issued on March 26, 1978 by former President Ferdinand E. Marcos;

WHEREAS, P.D. No. 1316 however, does not provide the description of its metes and bounds;

WHEREAS, Section 386 (b) of the Local Government Code of 1991 provides that "the territorial jurisdiction of the new Barangay shall be properly identified by metes and bounds or by more or less permanent natural boundaries";

WHEREAS, there is a need to define its boundaries and to plot its map to avoid conflict and disputes between and among adjacent barangays;

WHEREAS, the Joint Executive-Legislative Committee on Barangay Boundaries (JELCBB) conducted a public hearing on April 29, 2009 where both the Punong Barangay of Barangay Apolonio Samson and Barangay Balon-Bato mutually agreed to settle their boundary dispute;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. This Barangay shall be known as "Barangay Balon-bato"

SECTION 2. The boundaries of Barangay Balon-Bato shall be as follows:

Northeast: Southwestern boundary line of Lots 29-B, 29-A-2-E, Lot 1 (LRC) PCS-712

East: Eastern boundary line of Lots 30-TT-1, 4440-A, 444-B, 4439, 4438, 30-TTT, 4434-A-2, 4434-A-1, 4473, 4475-B, 4475-A

South: Southern boundary line of Lots 4475-A, 4474, 4434-A-3


Southwest: Creek at the western boundary line of Lots 4 and 1 (LRC) PCS-5054, 4422, 4424-B, 28-A-1-B, 28-A-1-A, 28-A-2-B-2-A and Lot 4 (SWO) 40777

Northwest: Quezon City - Caloocan boundary line

SECTION 3. Adopt the map hereto attached.


SECTION 4. This ordinance shall take effect upon its approval.
