ORDINANCE NO. SP-198,1s-2009

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF MONTVILLE WITH FORTY SEVEN (47) LOTS CONTAINING AN AGGREGATE AREA OF FIVE THOUSAND (5,000.00) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBER N-334527 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AS APPLIED FOR BY BENITO M. CERTEZA, (ATTORNEY –IN-FACT) WITH OFFICE ADDRESS AT #8 MADISON LOOP MONTGOMERY PLACE, E. RODRIGUEZ SR. AVENUE, QUEZON CITY, METRO MANILA, IN COMPLIANCE WITH THE MINIMUM REQUIREMENTS OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957 OR OTHERWISE KNOWN AS THE SUBDIVISION AND CONDOMINIUM BUYER'S PROTECTIVE DECREE.
