ORDINANCE NO. SP- 1976 S-2009

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY TO INCREASE THE PRICE OF THEIR ADMISSION TICKET BY ONE PESO (P1.00) COVERING THE PERIOD FROM FEBRUARY 1 TO 28, 2010 TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE FOUNDATION FOR RETIRED QUEZON CITY'S PRIDE, INC. (ASSOCIATION OF RETIRED POLICEMEN OF QUEZON CITY FOLICE DISTRICT).

Introduced by Councilors EDEN "Candy" A. MEDINA, VICTOR V. FERRER, JR., ANTONIO E. INTON, JR. and JESUS MANUL L. C. SUNTAY.

WHEREAS, the Foundation for Retired Quezon City's Pride, Inc. has been organized to promote the welfare of the retired policemen of the Quezon City Police District (QCPD);

WHEREAS, one of their programs is the continuous medical treatment of the ailing relired policemen who, due to old age, are suffering from various sickness and the scholarship grant for their children;

WHEREAS, due to limited funds and in order to support the said projects, there is on imperative need to seek the help of the private sector.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase their theater fees by One Peso (P1.00) covering the period from February 1 to 28, 2010.

SECTION 2. The proceeds of this fund raising project shall be used solely to finance the program and activities of the Foundation for Retired Quezon City's Price, Inc. SECTION 3. This Ordinance shall take effect immediately upon its approval.
