AN ORDINANCE APPROVING THE SUBDIVISION PLAN WITH EIGHTEEN (18) LOTS (DIRECT SALE) OF A SOCIALIZED HOUSING PROJECT UNDER THE COMMUNITY MORTGAGE PROGRAM OF A PARCEL OF LAND CONTAINING AN AREA OF ONE THOUSAND FIFTEEN (1,015.00) SQUARE METERS GROSS PROJECT AREA, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-44093 (53135) OF THE REGISTRY OF DEEDS OF QUEZON CITY, ... REGISTERED IN THE NAME OF JULITA E. BORERO MARRIED TO WILFREDO BORERO LOPEZ LOCATED AT LOT NO. FLS-2592-D. #69 SANTA VERONICA STREET, BARANGAY GULOD, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE BIGASAN (BORERO SAMAHANG MAGKAKAPIT-BAHAY NGASSOCIATION, INC., HOMEOWNERS PROPERTY REPRESENTED BY ITS PRESIDENT, MR. TIMOTEO S. LAGARA, AS A VARIANCE PURSUANT TO SECTION 9, RULE III OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF BATAS PAMBANSA BILANG 220.

WHEREAS, the Quezon City Council under the Local Government Code of 1991, is empowered to approve subdivision plans for residential, commercial and industrial purposes;

WHEREAS. strict observance of the standards requirements set by the Implementing Rules and Regulations of Batas Pambansan 220 on the submitted plan, as applied for by the Magkakapit-Bahay ng Bigasan (Borero Property) Homeowners Association, Inc., shows that out of 18 saleable lots there were 11 lots (16.00%) falls below the minimum standard of 32.00 square meters. Generally, this project can therefore be treated as a variance pursuant to Section 9, Rule III of the *Implementing* Standards, Rules and Regulations Pambansa Bilang 220, Moreover, this project is classified as on site "development and offered direct sale to the intended beneficiaries;

WHEREAS, pursuant to Section 9, Rule III of the Implementing Rules and Regulation of Batas Pambansan Bilang 220, relative to the aforementioned ground, variances or exceptions may be granted.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Subdivision Plan of Socialized Housing Project under the Community Mortgage Program of a parcel of land containing an area of One Thousand Fifteen (1,015.000) square meters, and is technically identified under Transfer Certificate of Title No. RT-44093 (56135) with Eighteen (18) lots located at Lot 178, Fls-2592-D, # 69 Sta. Veronica St., Barangay Gulod, Quezon City, Metro Manila, as applied for by the Samahang Magkakapit-Bahay ng Bigasan (Borero Property) Homeowners Association Inc. represented by its President, Mr. Timoteo S. Laraga, as a variance pursuant to Section 9, Rule III of the Implementing Rules and Regulation Batas Pambansa Bilang 220, is hereby approved.
