ORDINANCE NO. SP-1992S-2010

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS TO INCREASE ADMISSION TICKETS BY ONE PESO (P1.00) FOR THE ENTIRE MONTH OF MAY 2010, THE PROCEEDS THEREOF TO BE DONATED TO THE MOVIE WRITERS WELFARE FOUNDATION IN CONNECTION WITH ITS DEVELOPMENT PROJECT.

WHEREAS, Movie Writers Welfare Foundation is a non-stock, non-profit social welfare and educational foundation, which aims to develop and uplift the state of Philippine film culture through educational and development initiatives, responsive welfare programs, local and international linkage and partnership and resources generation;

WHEREAS, the Movie Writers Welfare Foundation undertakes social welfare programs that will redound to the benefit of Filipino writers;

WHEREAS, to show the support of the Quezon City Government, it intends to increase by One Peso (P1.00) the admission fees in cinemas within the city, the proceeds thereof to be donated to Movie Writers Welfare Foundation.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. All cinema and movie house owners and operators in Quezon City are hereby mandated to increase theater admission tickets by One Peso (P1.00) for the entire month of May 2010.

SECTION 2. The proceeds of the One Peso (P1.00) increase prescribed in Section 1 hereof shall be donated to the Movie Writers Welfare Foundation, in connection with its development projects.


SECTION 3. The City Treasurer is directed to submit a report of the sum collected for the purpose to the City Council prior to the release thereof to its lawful beneficiary, the Movie Writers Welfare Foundation.

SECTION 4. This Ordinance shall take effect upon its approval.


