ORDINANCE NO. SP-2009 1

AN ORDINANCE APPROVING THE SUBDIVISION PLAN WITH TWO HUNDRED FIFTY EIGHT SQUARE METERS AND TWENTY FIVE SQUARE DECIMETERS (258.25), LOCATED AT LOT 172-B, (LRC) PSD-270020, STA. VERONICA STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, A SOCIALIZED HOUSING PROJECT UNDER THE PROGRAM, MORTGAGE COVERED COMMUNITY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-13111 (241630) OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF FELINO M. CORTEZ AND ANITA E. CORTEZ AS APPLIED FOR BY THE KAAKBAY (F. CORTEZ) HOMEOWNER ASSOCIATION, INC., PHASE REPRESENTED BY ITS PRESIDENT, MS. GENEROSA P. GARCIA, AS A VARIANCE PURSUANT TO SECTION 9, RULE III STANDARDS, **IMPLEMENTING** RULES THE REGULATIONS OF BATAS PAMBANSA BILANG 220.

WHEREAS, the Quezon City Council, under the Local Government Code of 1991, is empowered to approve subdivision plans for residential, commercial and industrial purposes;



WHEREAS, strict observance of the standards and requirements set by the Implementing Rules and Regulations of B. P. Blg., 220 on the submitted plan, as applied for by the Kaakbay (F. Cortez) Homeowners Association, Inc., shows that all lots falls below the minimum Standard of Batas Pambasa Bilang 220. Generally this project can therefore, be treated as a variance pursuant to Section 9, Rule III of the Implementing Standards, Rules and Regulations of Batas Pambasa Bilang 220. Moreover, this CMP Project is classified as an "on site" development and originated by the Quezon City Government under UPAO;

WHEREAS, pursuant to Section 9, Rule III of the Implementing Rules and Regulations of Batas Pambansa Bilang 220 relative to the aforementioned ground, variances or exception may be granted.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Subdivision Plan of Socialized Housing Project under the Community Mortgage Program of a Parcel of land containing an area of Two Hundred Fifty Eight Square Meters and Twenty Five Decimeters (258.25 sq.m) and is technically identified under Transfer Certificate of Title Numbered RT-13211, located at Lot 172-B, (LRC) PSD-270020, Sta. Veronica Street, Barangay Gulod, Quezon City Metro Manila, as applied for by the Kaakbay (F. Cortez) Homeowners Inc., represented by its President Ms. Generosa P. Garcia, as a variance pursuant to Section 9, Rule III of the Implementing Standards, Rules and Regulations of Batas Pambansa Bilang 220, is hereby approved. Details of which are as follows:
