ORDINANCE NO. SP-2014S-2010

AN ORDINANCE APPROVING THE SUBDIVISION PLAN WITH EIGHTEEN (18) LOTS COMMUNITY MORTGAGE PROGRAM (CMP) PROJECT CONTAINING AN AREA OF FIVE HUNDRED FORTY (540.00) SQUARE METERS GROSS PROJECT AREA, REGISTERED IN THE NAME OF PHILIPPINE NATIONAL BANK AND COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-174662 AND N-174663 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 2, BLOCK 5 AND LOT 11, BLOCK 1 KASIYAHAN STREET, BARANGAY HOLY SPIRIT, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY GOAL ACHIEVER HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY ITS PRESIDENT, MR. ISABELO P. MERCADO, AS VARIANCE PURSUANT TO SECTION 9, RULE III OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF BATAS PAMBANSA BILANG 220.

WHEREAS, the Quezon City Council under the Local Government Code of 1991, is empowered to approve subdivision plans for residential, commercial and industrial purposes;

WHEREAS, strict observance of the standards and requirements set by the Implementing Rules and Regulations of Batas Pambansa Bilang 220, on the submitted plan as applied for by Mr. Isabelo P. Mercado, the proposed subdivision plans shows that out of 18 lots there were 6 lots that falls below the minimum revised standard of 26.0 square meters. Generally, this project is treated as a variance pursuant to Section 9, Rules and Regulations of Batas Pambasa Bilang 220 and this project is classified as "on site" development and originated by the Quezon City Government under UPAO.
