ORDINANCE NO. SP- **1987** -S-2010

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY TO INCREASE THE PRICE OF THEIR ADMISSION TICKET BY ONE PESO (P1.00) FOR THE ENTIRE MONTH OF MARCH 2010 FOR THE PURPOSE OF SUPPORTING THE SCOUTING PROGRAM OF THE QUEZON CITY GIRLS SCOUT.

WHEREAS, the Girls Scout Movement, which serves as a training ground for young women, needs our support for its project/program and activities through minimal contributions of the general public.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase the price of their admission ticket by One Peso (P1.00) for the entire month of March 2010.

SECTION 2. All proceeds from this fund raising shall be used exclusively to finance all programs and activities of the Quezon City Girls Scouts.

SECTION 3. The City Treasurer is directed to submit a report of the sum collected for the purpose to the City Council prior to the release thereof to its lawful beneficiary, the Girls Scout of the Philippines, Quezon City Chapter.


SECTION 4. This Ordinance shall take effect upon its approval.


