ORDINANCE

ALLOCATING THE SUM OF SEVEN THOUSAND SEVEN HUNDRED TWENTY-THREE PESOS (P7,723.00) OR SO MUCH THEREOF TO COVER THE SALARY DIFFERENTIAL OF MRS. ROSARIO V.E. REYES AS ACTING ASSISTANT CITY TREASURER COVERING THE PERIOD FROM JULY TO DECEMBER 1992 AND JANUARY TO MAY 1993, THE SAME TO BE TAKEN FROM THE SALARY SAVINGS OF THE OFFICE OF THE CITY TREASURER.

WHEREAS, the regular incumbent Assistant City Treasurer, Teodoro R. Pauline went on a leave of absence from July 1, 1992 until his compulsory retirement on May 20, 1993;

WHEREAS, Mrs. Rosario V.E. Reyes was appointed as Acting Assistant City Treasurer effective July 1, 1992 and is still holding that position up to the present;

WHEREAS, the Department of Finance requires a Council Resolution to cover the salary differential of Mrs. Reyes as Acting Assistant City Treasurer from July 1, 1992 up to May 1993 which is computed as follows:

WHEREAS, the above amount will be taken from salary savings in the 1993 Annual Budget of the City Treasurer arising out of unfilled positions in that Office;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby allocated the sum of Seven Thousand Seven Hundred Twenty-Three Pesos ((P7,723.00) or so much thereof to cover the payment of the salary differential of Mrs. Rosario V.E. Reyes, Acting Assistant City Treasurer, covering the period from July to December 1992 and from January to May 1993, the same to be taken from salary savings in the 1993 Annual Budget of the Office of the City Treasurer arising out of unfilled positions in that office.
