THE SPECIAL PROJECT FUND OF THE CITY MAYOR NECESSARY TO COVER THE ALLOWANCES OF ONE HUNDRED FIFTY—THREE (153) BARANGAY
NUTRITION SCHOLARS FOR THE SERVICES AND CONTINUATION OF OPERA—
TION AND INCREASE OF THEIR ALLOWANCES FROM ONE THOUSAND PESOS
(\$\frac{1}{2}\$,000.00) TO TWO THOUSAND PESOS (\$\frac{1}{2}\$,000.00).

WHEREAS, our Constitution and the Local Government Code of 1991 provide among others for the delivery of basic services and facilities which include but are not limited to health and social welfare services;

WHEREAS, in pursuance of the above objective, particularly in addressing the problem of malnutrition, Presidential Decree No. 1569 was signed into law in 1978 deploying Barngay Nutrition Scholars (BNS) in the four (4) cities and thirteen (13) municipalities comprising Metropolitan Manila and allocating funds for its purpose;

WHEREAS, to squarely address this problem of malnutrition, the President of the Philippines issued on June 17, 1978, Presidential Decree No. 1569 entitled "Strengthening the Barangay Nutrition Program by Providing for a Barangay Nutrition Scholar in every barangay;

WHEREAS, in consonance with the spirit and contemplation of the aforesaid Presidential Decree, the quezon City Government constituted the Quezon City Barangay Nutrition Scholars tasked primarily with the functions and responsibilities of delivering basic nutrition services and other related services such as community health, environmental sanitation, family pranning and natal feeding in the different barang on the City specials in the depressed areas:
