ORDINANCE

GRANTING LICENSE TO LA LOMA COCKPIT TO HOLD SPECIAL COCKFIGHTS ON MAY 11 AND 12, 1993 IN OBSERVANCE OF THE FEAST OF NUESTRA SEÑORA DE SALVACION OF LA LOMA DISTRICT, QUEZON CITY.

WHEREAS, pursuant to Sec. 458, Sub-par. (5) of R.A. No. 7160, the Sangguniang Panglungsod is empowered to authorize and license the establishment, operation and maintenance of cockpits, and regulate cockfighting and commercial breeding of game cocks;

WHEREAS, a Barangay Resolution No. 017-93 of Barangay Salvacion has been passed authorizing the Council of said Barangay to hold special cockfights on May 11 and 12, 1993 at the La Loma Cockpit Arena located at Calavite Street, La Loma, Quezon City;

WHEREAS, letter request dated April 30, 1993 by the Chairman of Barangay Salvacion has been relayed to the City Mayor for the issuance of special permit for the said special cockfights;

NOW, THEREFORE

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. The La Loma Cockpit is hereby granted


a license to hold cockfights on May 11 and 12, 1993 in observance of the Feast of Nuestra Señora De Salvacion of La Loma District, Quezon City.


